#### Could Increased Cybersecurity mean a Lack of Trust?

Many companies and firms are now using artificial intelligence as a means of streamlining data management and analytics. This is one of the benefits of technology within the legal industry.

An average person might assume that the files contained on lawyers' computers are mere documents, however, these documents contain not only privileged information about their clients, but about their business itself.

No business in any industry in Ireland can ignore what has happened within the media in recent months and the threats that were presented with it. The latest cyber-attack on the HSE making the headlines is one of an extremely large scale and has set forth changes that need to be done to protect businesses from It happening to them.

When we first think of trust we think of an assured reliance on a person's character, ability, strength or the truth of someone or something. It's a sense of confidence and dependability on the future or contingent. However, trust is fragile, once it has been lost it can be hard to rebuild. We may see this more often in politics.

As we become to depend more and more on technology, there is also an increased amount in trust issues with cyber threats and vulnerabilities. These may appear as fake digital certificates, vulnerable software, and stolen credentials.

By working together with other businesses and organisations, we can share threat intelligence with our trusted peers which is critical in surviving this fast-evolving threat environment.

#### How you can protect your data online.

Keep your accounts secure by creating a strong password and keeping a personal note on them in a safe place. Also remember to change your passwords regularly. And be mindful of what you post on social media, consider who might have access to your posts.

Protect your internet browsing. The next time you go online just look at the top of your browser. You may notice that there is a padlock right at the start of the address bar and that it begins with "https", these indicate that the website you want access to will be secure and safe to proceed.

Stay up to date with the correct protection software such as anti-virus, anti-spyware, and a firewall. These can all be accessed in your local computer store or from trusted websites.

Use secure private networks, free WIFI may seem convenient at the most of times, but it should also be used with caution. Most public networks have very little security measures in place. If you intend to do some online shopping or access anything that need your card details, it may be best to wait until you get home where it is more secure before you consider whipping out your bankcard.

If you do suspect your data may be compromised, act immediately by calling your bank server and put a hold on any charges to your account and notify the Gardai.
